### ADDENDUM TO CHARTER CONTRACT

In this addendum, 'The Charterer' refers to the party contracted to hire the chartered yacht from Horizon Yacht Charters Ltd. pursuant to the charter contract dated [ ] to which this addendum is affixed (the Charter Contract) and the terms of this addendum shall apply to all crew aboard the chartered yacht.

This addendum is to be read in conjunction with the terms of the Charter Contract and terms not otherwise defined herein shall have the same meaning as in the Charter Contract.

Considering the current Covid-19 pandemic, it is necessary to add these new Protocols to all Charter Contracts commencing from December 1<sup>st</sup>, 2020.

- (1) The Government of the British Virgin Islands has issued protocols for international visitors (see: <https://bvi.gov.vg/covid-19> and please note that these pages are updated occasionally). The Charterer will comply with all the laws, rules, and regulations regarding the BVI Government's entry and quarantine protocols and abide by all the stipulations, paying special attention to marine requirements. Failure to comply with any protocols may result in termination of your Charter with Horizon Yacht Charters Ltd and any fines or other costs will be at the cost of the Charterer.
- (2) The Charterer will ensure that all persons over the age of 5 years will wear a mask in public places, maintain social distancing and wash hands/sanitize hands as mandated by the BVI Government.
- (3) The Charterer understands the limitations of the quarantine period, the length of quarantine, where you can go and what you can and cannot do as set out by the protocols of the BVI Government.
- (4) The Charterer will go to a Covid-19 testing facility on your 4<sup>th</sup> full day of quarantine as mandated by the BVI Government.
- (5) In the event that any member of the crew tests positive, the Charterer will return to the marina immediately, calling Horizon beforehand for a slip allocation. The Charterer understands that quarantine will either be aboard if the Yacht is available or the Charterer will be moved to a Government quarantine facility. The Charterer understands that quarantine accommodation where applicable, will be payable in advance by the Charterer, and it will be the Charterer's responsibility to seek reimbursement from the Covid 19 Insurance policy which is compulsory for travel to the BVI.
- (6) The Charterer acknowledges that if there are any lockdowns or restrictions of movement, the Charterer will return to base immediately and adhere to the protocols.
